## **SYARAT BAGI URUSAN “NOTICE OF CHANGE”**

1. Nyatakan butir-butir yang perlu diubah di boring “NOTICE OF CHANGE” dengan jelas dan menggunakan Bahasa Malaysia.
2. Borang hendaklah ditandatangani oleh Pemegang Lesen
3. Permohonan yang melibatkan pembatalan nama Pemegang Lesen harus mematuhi suarat-syarat berikut:-
  - A) Tandatangan Pemegang Lesen yang keluar harus disaksikan oleh Pegawai Pelesenan atau Pesurujaya Sumpah atau Justice of Peace atau mana-mana Pegawai yang diberi kebenaran oleh Pegawai Pelesenan atau dengan menyatakan Surat Akuan Bersumpah.
  - B) Sebagai tambahan kepada Perkara 3(A) di atas, permohonan pembatalan nama pengurus / agen oleh Syarikat yang berdaftar dengan Pendaftaran Pertubuhan perlu dibuat secara bertulis dan menyertakan sesalinan Form 49 & Form 24.
4. Permohonan yang melibatkan pindah tempat perniagaan (premis) harus mematuhi syarat-syarat berikut :-
  - A) Mengisi boring permohonan Pertukaran Lokasi Premis dengan lengkap.
  - B) Menyatakan salinan surat perjanjian atau Surat kebenaran menggunakan premis bagi permohonan-permohonan yang menggunakan / menyewa premis tersebut.
  - C) Menyertakan salinan Geran Tanah yang disahkan benar bagi premis perniagaan terletak di kawasan luar Bandar.
